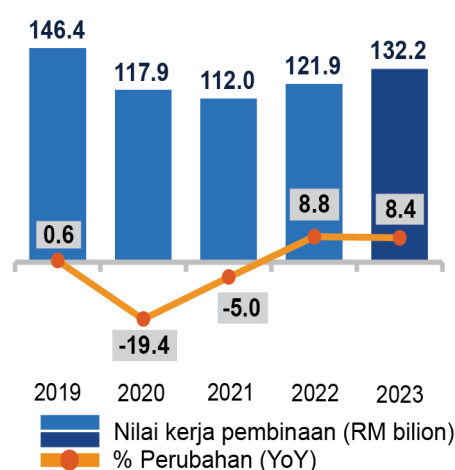

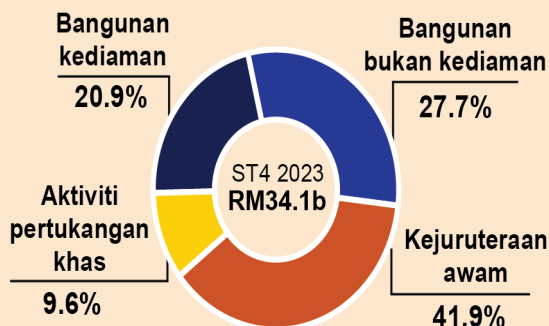

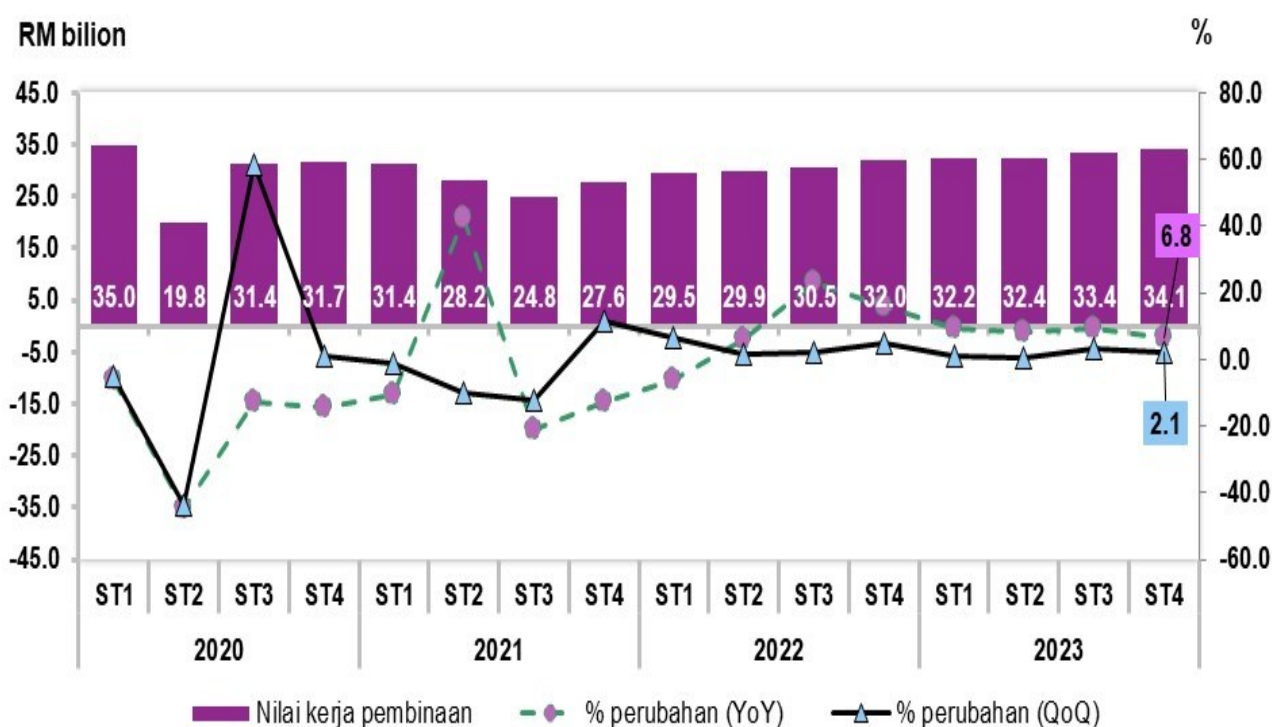

RINGKASAN PENEMUAN

1. Prestasi Sektor Pembinaan

Nilai kerja pembinaan pada suku keempat 2023 kekal bertumbuh dengan mencatatkan peningkatan sebanyak 6.8 peratus (ST3 2023: 9.6%) berasaskan tahun ke tahun, berjumlah RM34.1 bilion (ST3 2023: RM33.4 bilion). Sementara itu, perbandingan suku tahun ke suku tahun menunjukkan nilai kerja pembinaan meningkat pada 2.1 peratus pada suku tahun keempat 2023 seperti di Carta 1.

Carta 1: Nilai kerja pembinaan dan perubahan peratus, ST1 2020 - ST4 2023

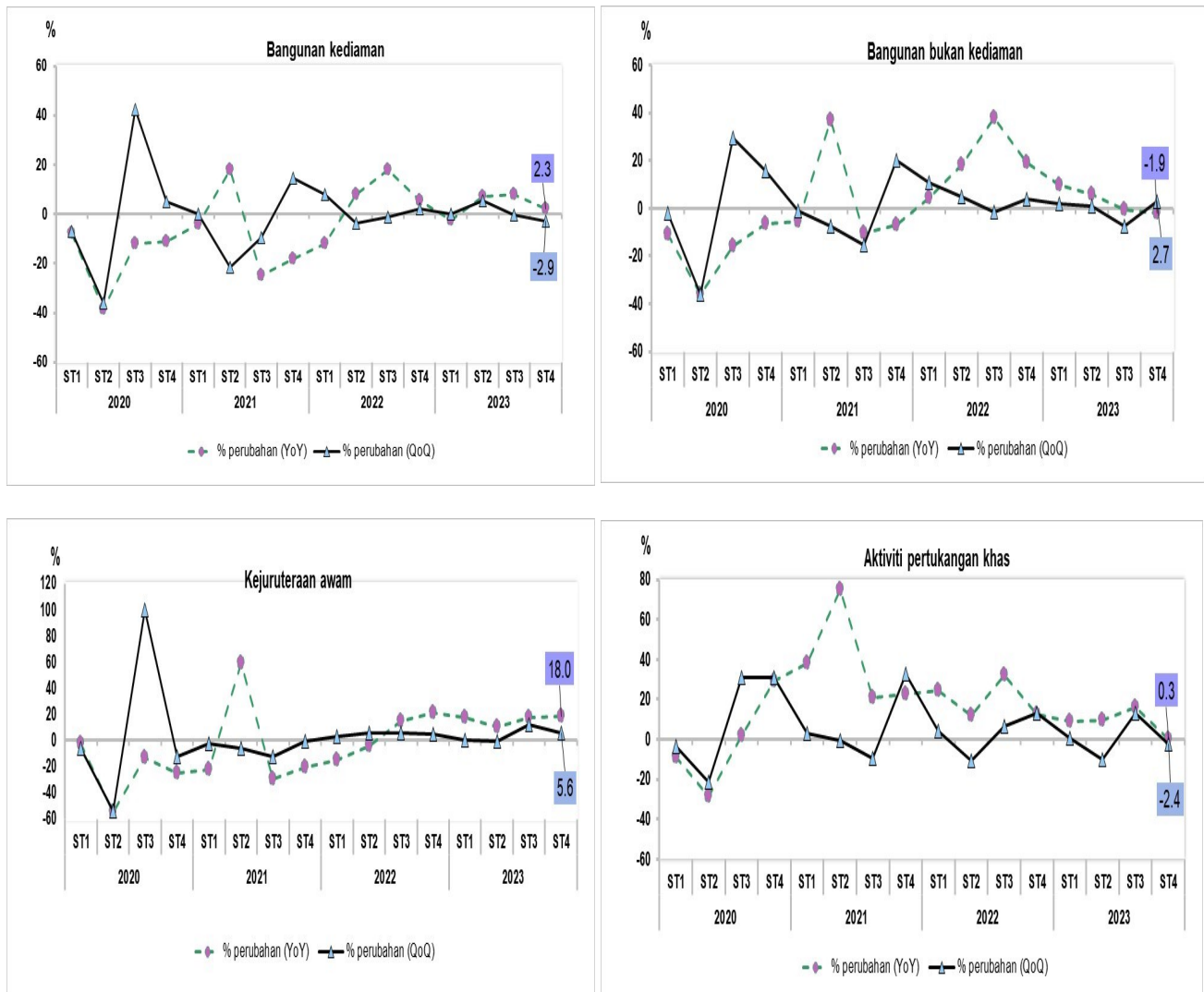


2. Prestasi mengikut Subsektor

Peningkatan dalam sektor Pembinaan pada suku keempat 2023 dipacu oleh pertumbuhan dua digit dalam subsektor Kejuruteraan awam dengan pertumbuhan sebanyak 18.0 peratus (ST3 2023: 17.1%). Manakala, Bangunan kediaman dan Aktiviti pertukangan khas berkembang pada kadar lebih perlahan masing-masing pada 2.3 peratus (ST3 2023: 7.9%) dan 0.3 peratus (ST3 2023: 16.2%). Sebaliknya, subsektor Bangunan bukan kediaman mengalami penurunan 1.9 peratus (ST3 2023: -0.7%) seperti di Carta 2.

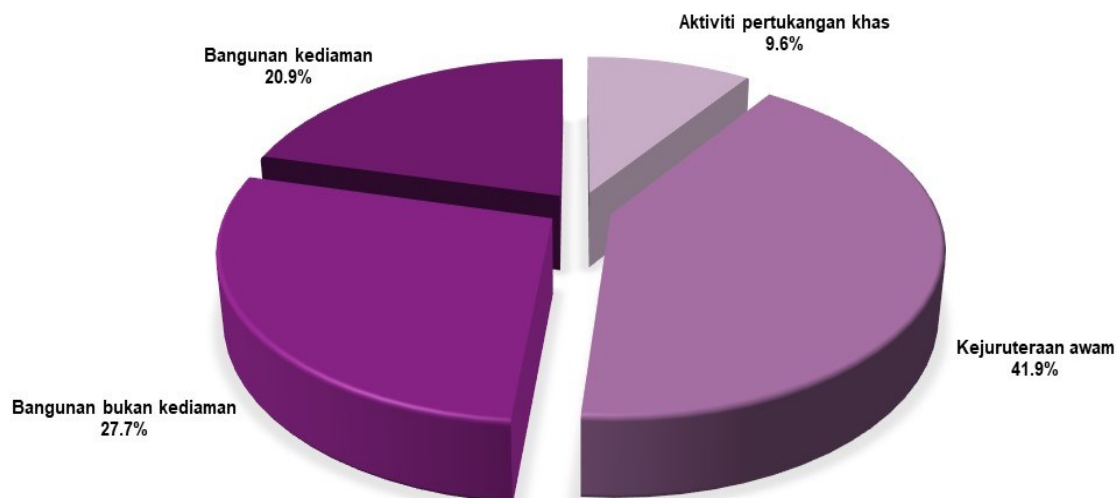
Subsektor Bangunan bukan kediaman melonjak dengan merekodkan pertumbuhan positif dalam perbandingan suku tahun ke suku tahun sebanyak 2.7 peratus. Pada masa yang sama, subsektor Kejuruteraan awam mengekalkan pertumbuhan yang positif dengan 5.6 peratus berbanding suku yang lepas. Manakala, subsektor Aktiviti pertukangan khas dan Bangunan kediaman masing-masing menguncup kepada 2.4 peratus dan 2.9 peratus seperti di Carta 2.

Subsektor Kejuruteraan awam kekal sebagai penyumbang utama nilai kerja pembinaan, dengan sumbangan terbesar sebanyak 41.9 peratus, diikuti oleh subsektor Bangunan bukan kediaman dengan sumbangan sebanyak 27.7 peratus, manakala subsektor Bangunan kediaman dan Aktiviti pertukangan khas masing-masing menyumbang sebanyak 20.9 peratus dan 9.6 peratus seperti di Carta 3.

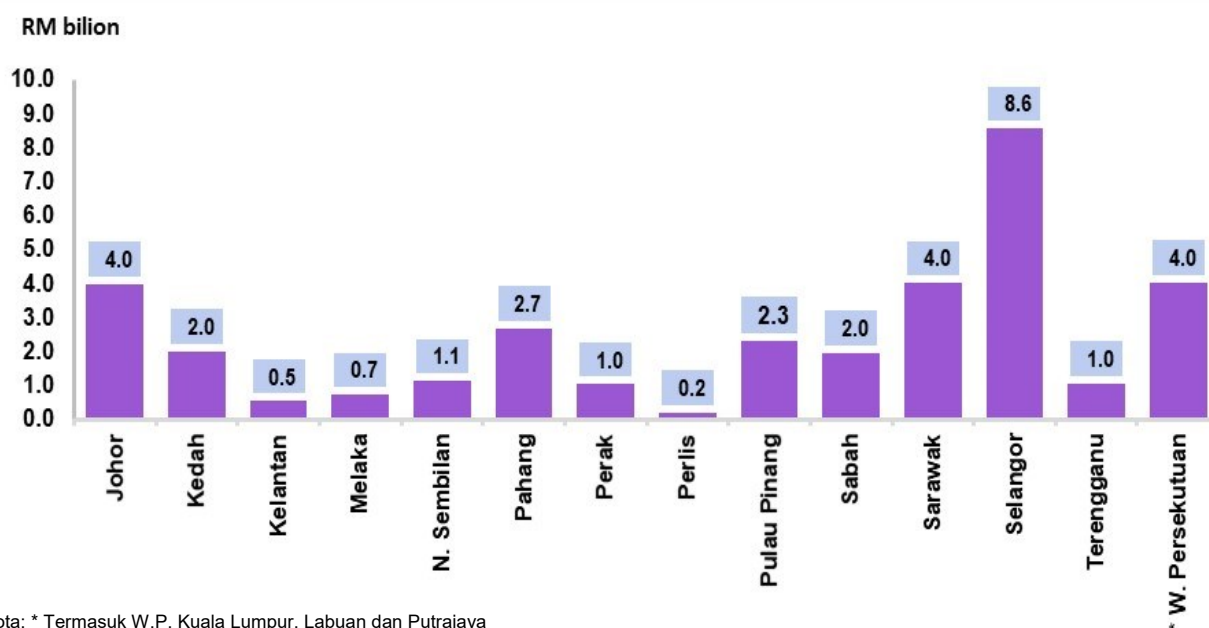
Carta 3: Peratus sumbangan nilai kerja pembinaan mengikut subsektor, ST4 2023



3. Nilai Kerja Pembinaan mengikut Lokasi Projek

Selangor merekodkan nilai kerja pembinaan tertinggi iaitu sebanyak RM8.6 bilion atau 25.1 peratus. Sementara itu, Wilayah Persekutuan menduduki tempat kedua dengan sejumlah RM4.0 bilion atau 11.8 peratus. Selain itu, Sarawak dan Johor kedua-duanya mencatatkan nilai kerja sebanyak RM4.0 bilion. Keempat-empat negeri ini secara kolektif menyumbang RM20.6 bilion atau 60.3 peratus daripada nilai kerja pembinaan seperti di Carta 4.

Carta 4: Nilai kerja pembinaan mengikut lokasi projek, ST4 2023

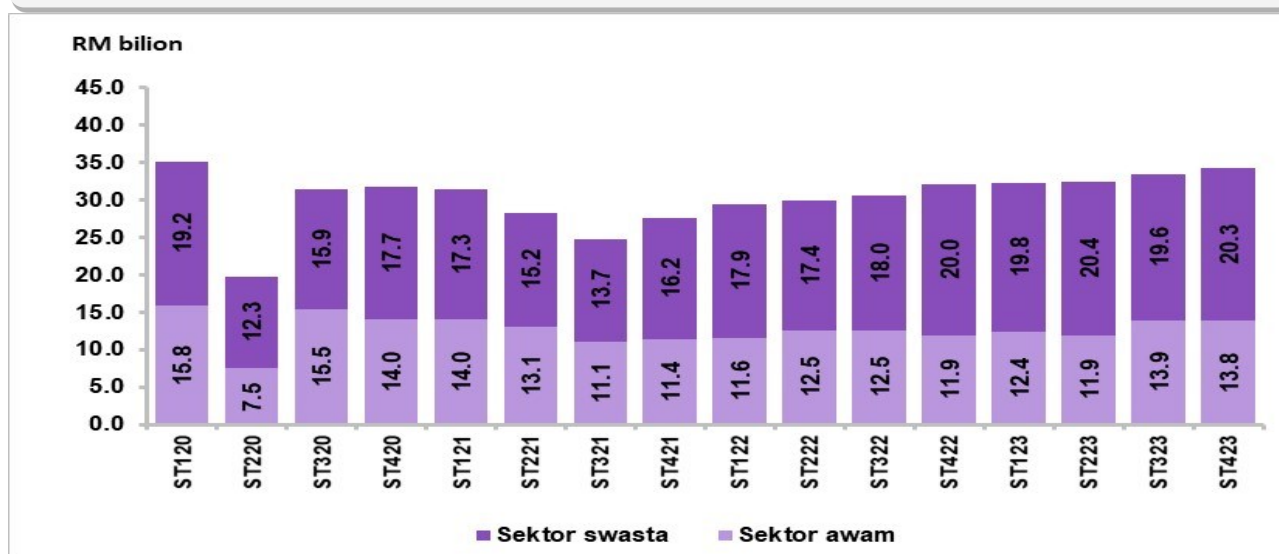

4. Pembinaan mengikut Pemilik Projek

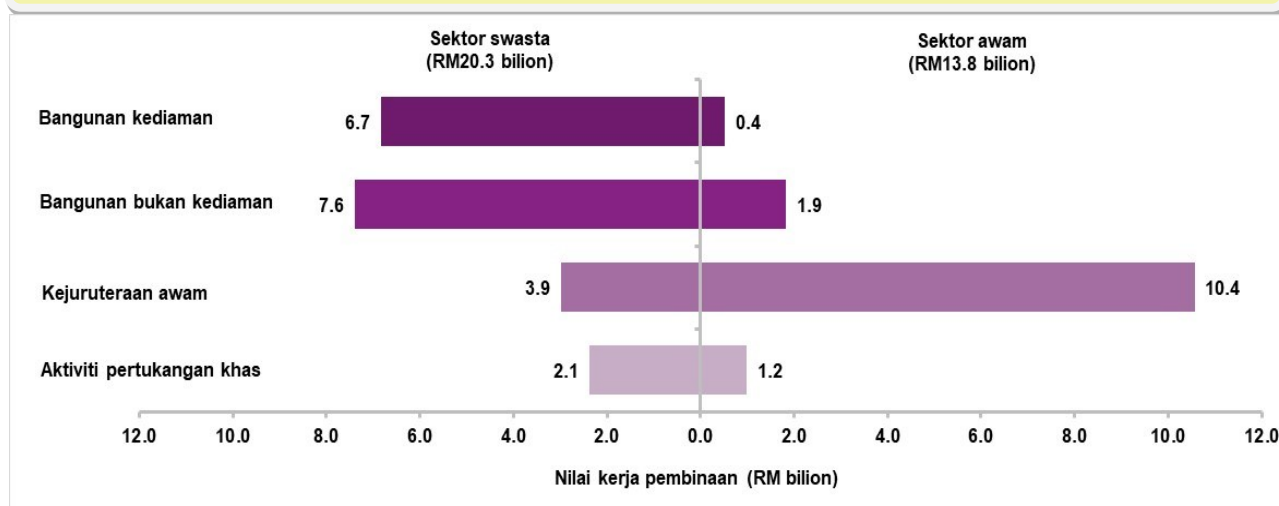
Sektor swasta tumbuh sederhana 1.4 peratus (ST3 2023: 8.6%) dengan menyumbang 59.5 peratus daripada nilai kerja pembinaan (RM20.3 bilion) dan sektor awam menunjukkan peningkatan yang memberangsangkan kepada 15.9 peratus (ST3 2023: 10.9%) dengan sumbangan 40.5 peratus daripada nilai kerja pembinaan (RM13.8 bilion) seperti di Carta 5.

Nilai kerja pembinaan subsektor Bangunan bukan kediaman dan Bangunan kediaman kekal signifikan bagi projek yang dimiliki sektor swasta iaitu masing-masing menyumbang sebanyak 37.3 peratus (RM7.6 bilion) dan 33.1 peratus (RM6.7 bilion). Selain itu, projek milikan sektor awam pula disokong oleh subsektor Kejuruteraan awam dengan sumbangan sebanyak 75.1 peratus (RM10.4 bilion) seperti di Carta 6.

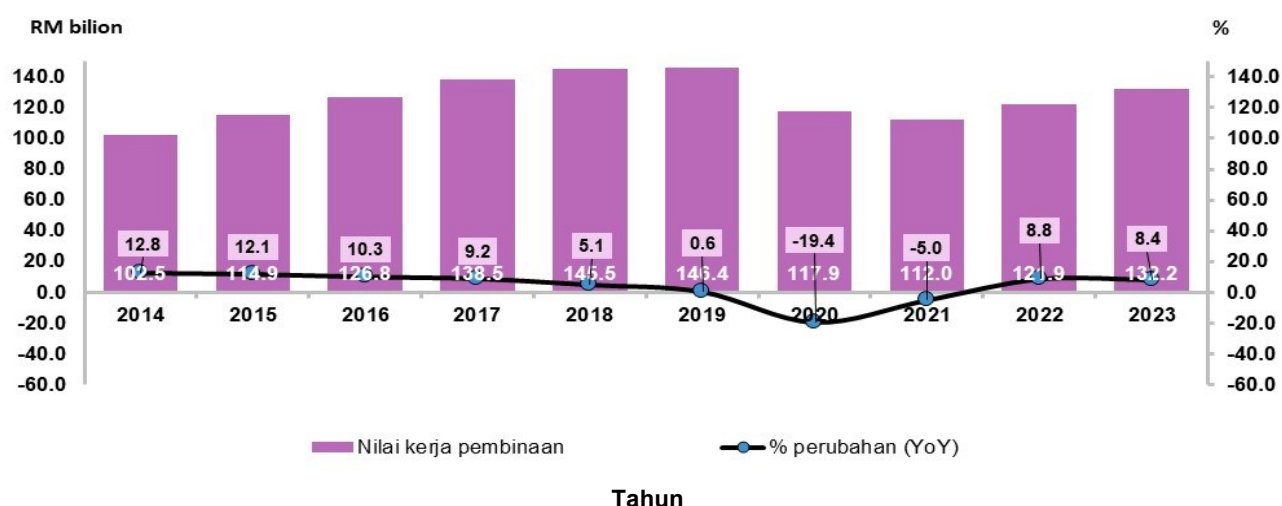
Carta 6: Nilai kerja pembinaan mengikut pemilik projek dan subsektor, ST4 2023



5. Nilai Kerja Pembinaan Tahunan

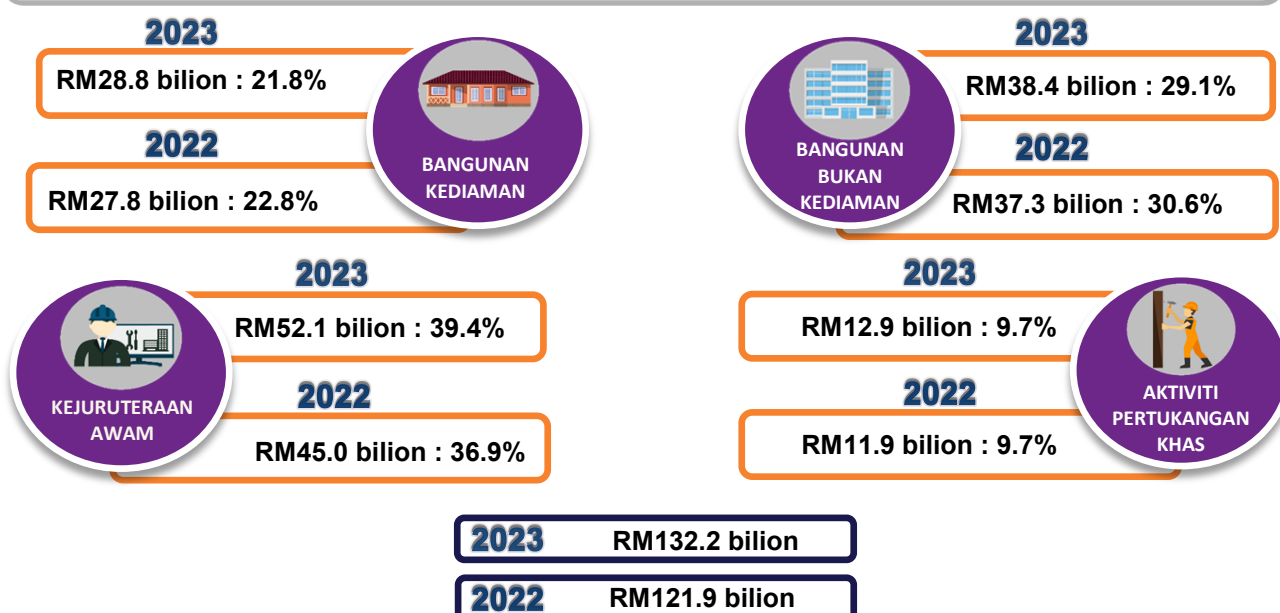
Pada tahun 2023, nilai kerja pembinaan menunjukkan momentum positif yang berterusan pada 8.4 peratus (2022: 8.8%) kepada RM132.2 bilion berbanding RM121.9 bilion pada 2022 seperti di Carta 7.

Semua subsektor mencatatkan pertumbuhan yang positif dalam nilai kerja pembinaan seperti berikut: Subsektor Kejuruteraan awam (15.7%), diikuti oleh Aktiviti pertukangan khas (8.5%), Bangunan kediaman (3.7%) dan Bangunan bukan kediaman (3.1%). Subsektor Kejuruteraan awam dan Bangunan bukan kediaman mewakili lebih dua pertiga daripada jumlah nilai kerja pembinaan pada 2023 seperti di Paparan 1.

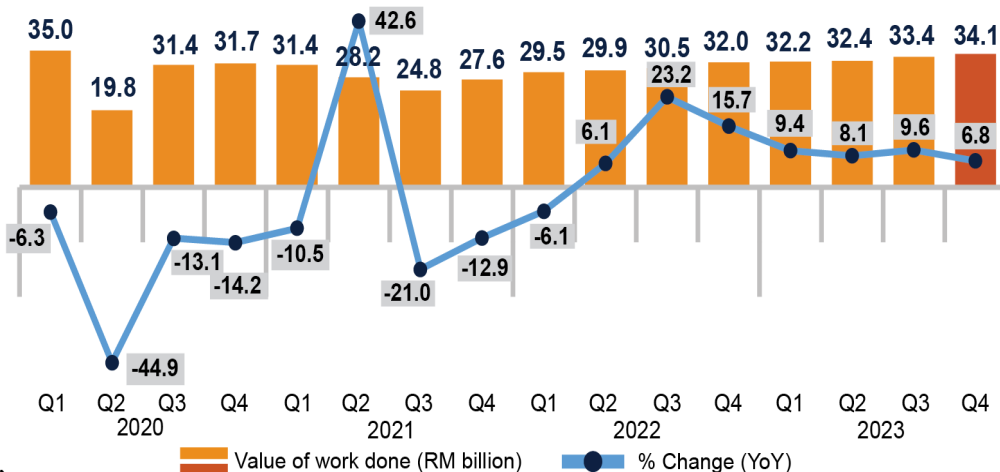

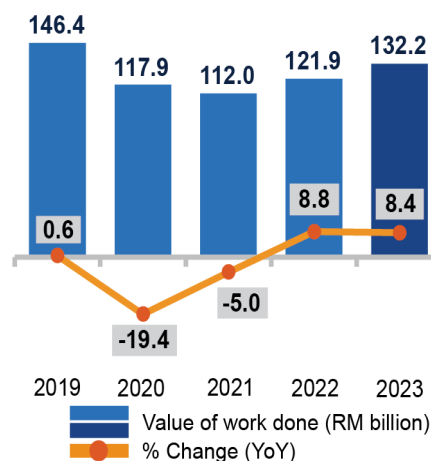

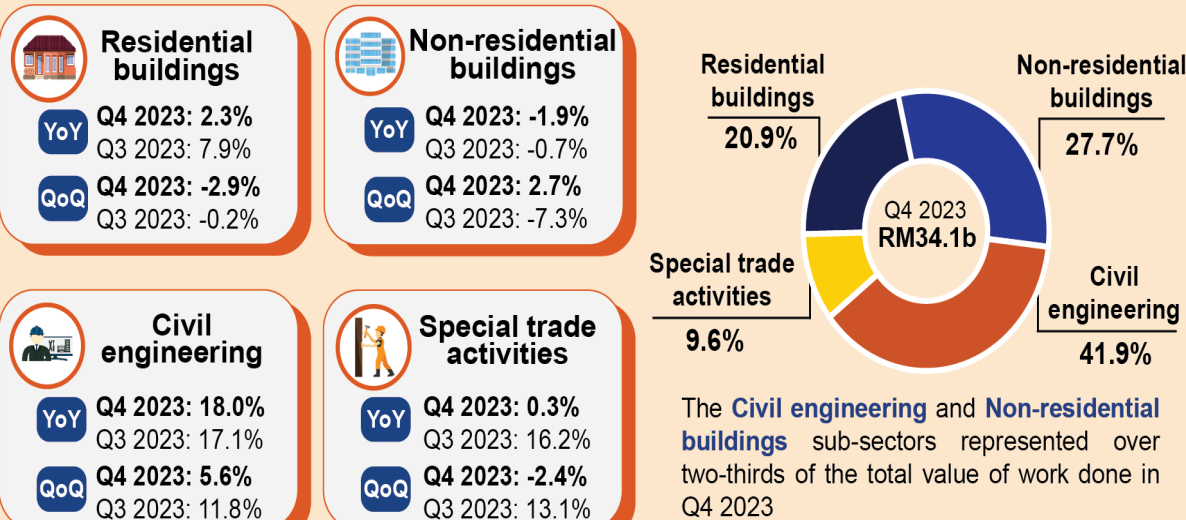
Value of work done Q1 2020 - Q4 2023

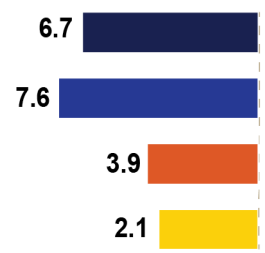

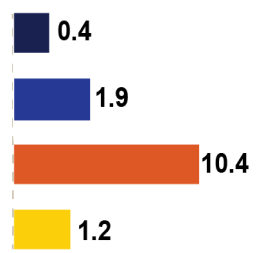

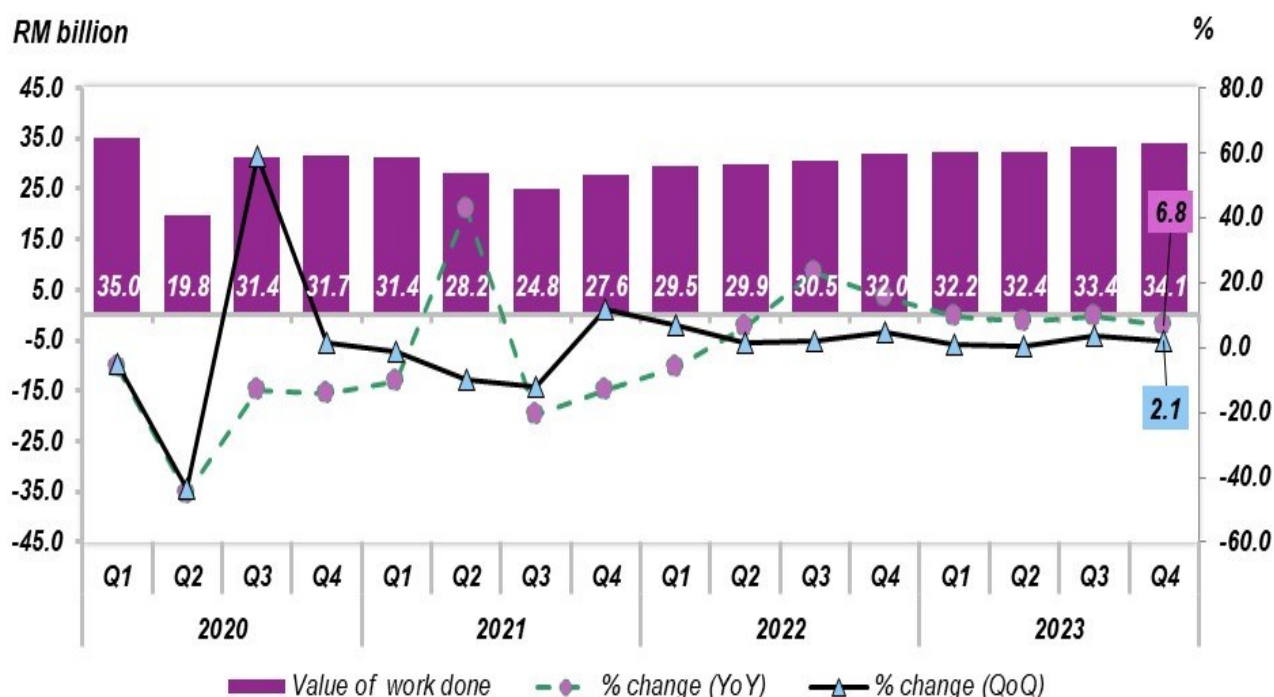

SUMMARY OF FINDINGS

1. Performance of The Construction Sector

The value of work done in the fourth quarter 2023 remained increased by 6.8 per cent (Q3 2023: 9.6%) year-on-year basis, amounting to RM34.1 billion (Q3 2023: RM33.4 billion). Meanwhile, a quarter-on-quarter comparison showed the value of work done increased 2.1 per cent in the fourth quarter 2023 as in Chart 1.

Chart 1: Value of work done and percentage change, Q1 2020 - Q4 2023

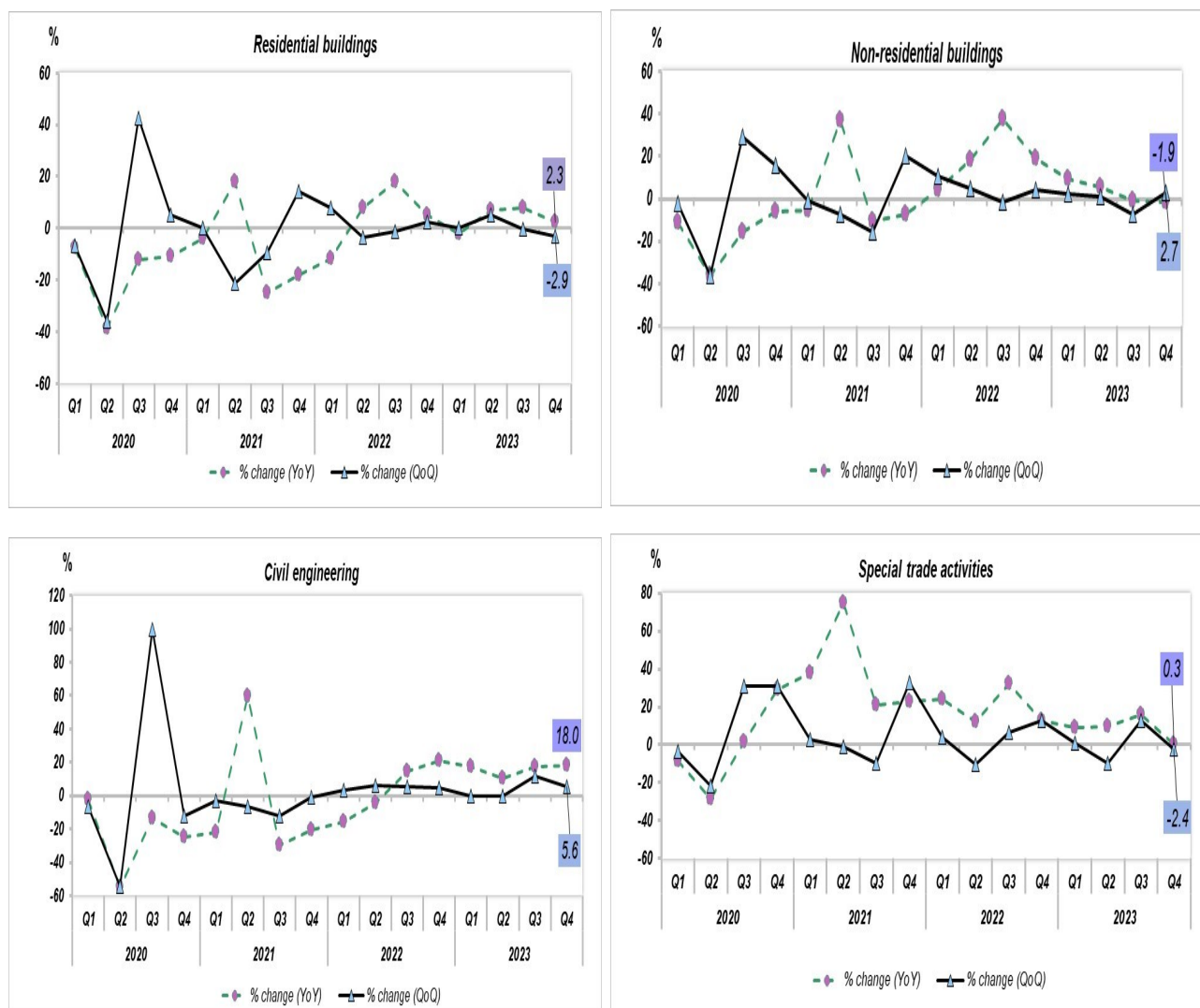


2. Performance by Sub-sector

The increment of the Construction sector in the fourth quarter was driven by double-digit growth in Civil engineering sub-sector with a growth by 18.0 per cent (Q3 2023: 17.1%). Meanwhile, the Residential buildings and Special trade activities expanded at a slower pace of 2.3 per cent (Q3 2023: 7.9%) and 0.3 per cent (Q3 2023: 16.2%) respectively. In contrast, the Non-residential buildings sub-sector experienced a decline of 1.9 per cent (Q3 2023: -0.7%) as in Chart 2.

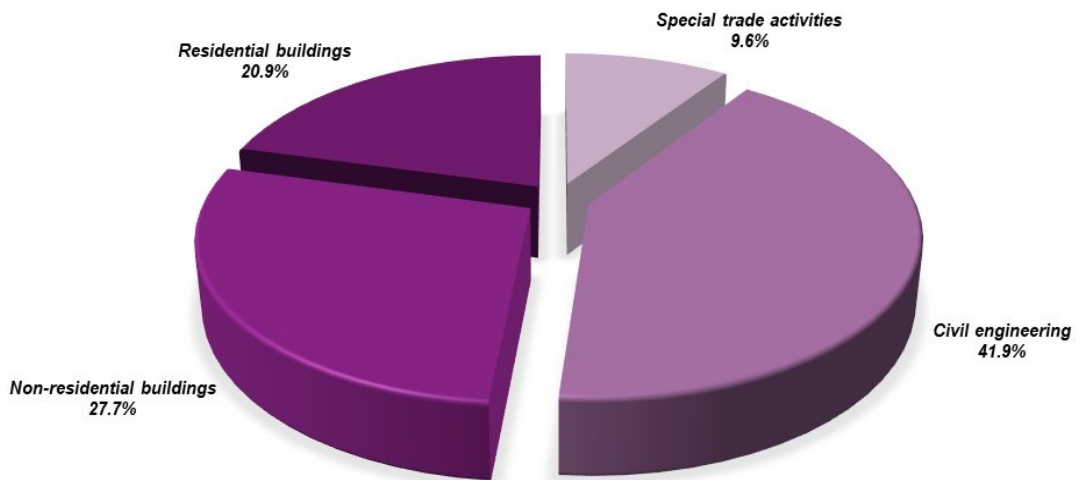
Non-residential buildings sub-sector rebounded with recorded positive growth in a quarter-on-quarter comparison of 2.7 per cent. In the meantime, Civil engineering sub-sector sustained positive growth with 5.6 per cent as compared to the last quarter. In contrast, the Special trade activities and the Residential buildings sub-sectors contracted to 2.4 per cent and 2.9 per cent respectively as in Chart 2.

Civil engineering sub-sector remained as the main contributor to the overall value of construction work done, holding the largest share of 41.9 per cent, followed by Non-residential buildings sub-sector with a share of 27.7 per cent, while Residential buildings and Special trade activities sub-sectors contributed 20.9 per cent and 9.6 per cent respectively as in Chart 3.

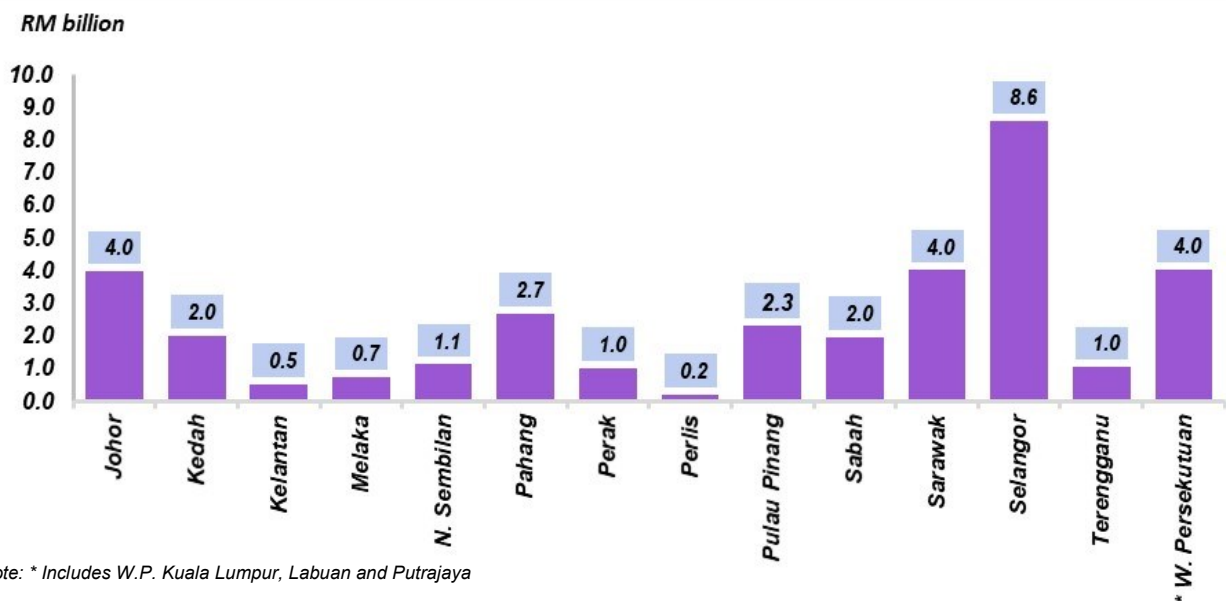
Chart 3: Percentage share value of work done by sub-sector, Q4 2023



3. Value of Work Done by Location of Project

Selangor recorded the highest value of construction work done at RM8.6 billion or 25.1 per cent. Meanwhile, Wilayah Persekutuan ranked second with a value of RM4.0 billion or 11.8 per cent. Additionally, both Sarawak and Johor recorded a work value of RM4.0 billion. These four states collectively made up RM20.6 billion or 60.3 per cent of the total value work of done as in Chart 4.

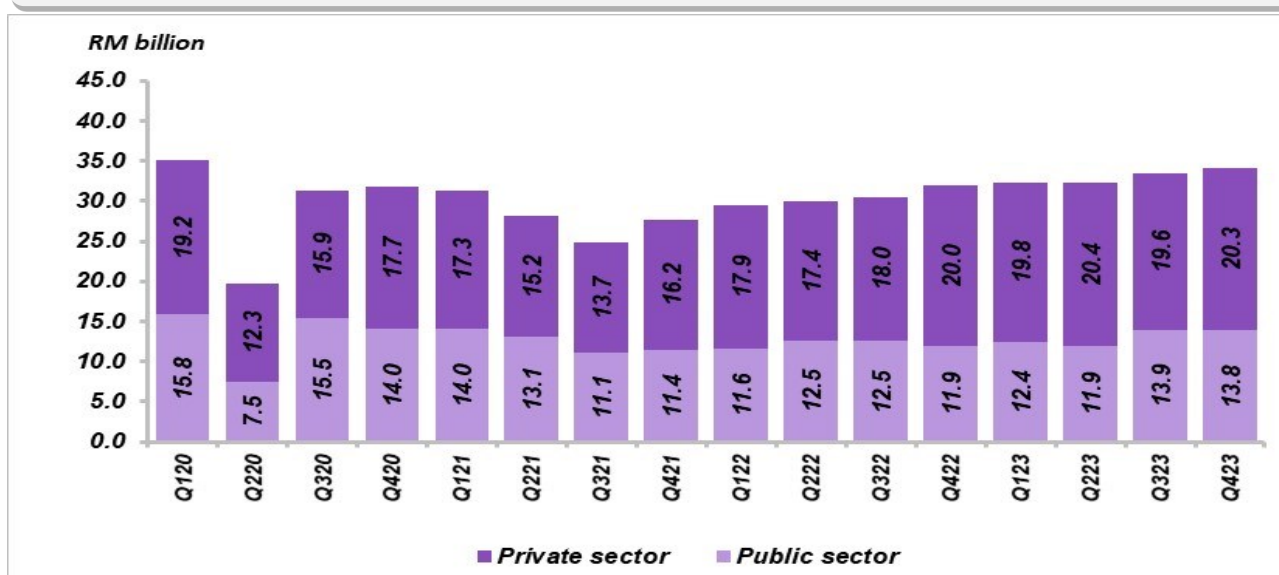
Chart 4: Value of work done by location of project, Q4 2023

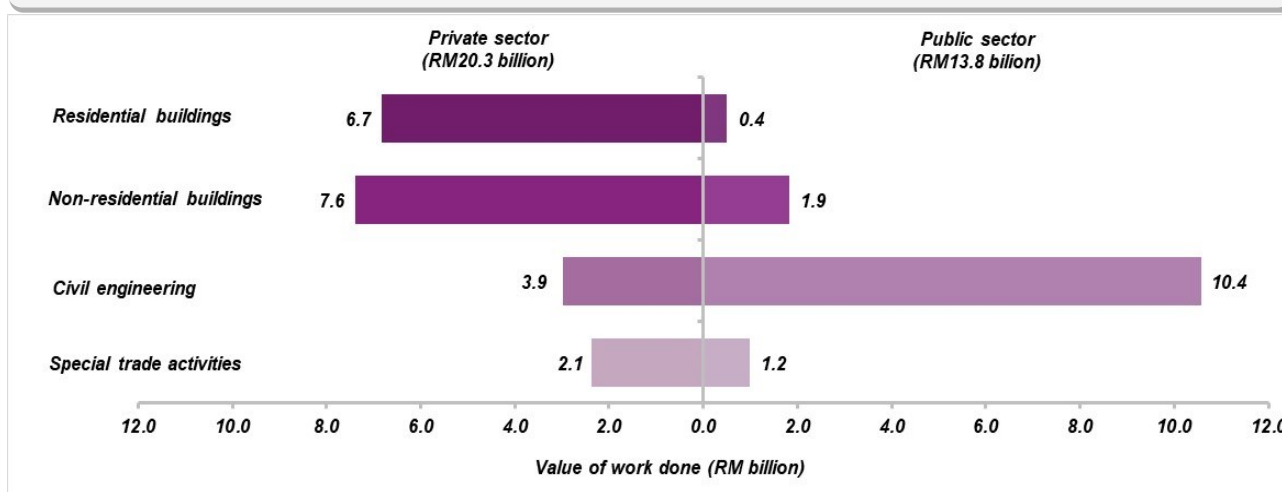
Private sector grew modestly 1.4 per cent (Q3 2023: 8.6%) with 59.5 per cent share of total value of work done (RM20.3 billion) and the public sector showed perform favourably by 15.9 per cent (Q3 2023: 10.9%) with 40.5 per cent share of total value of work done (RM13.8 billion) as in Chart 5.

The value of work done in Non-residential buildings and Residential buildings sub-sectors remained significant in the project owned by the private sector which contributed 37.3 per cent (RM7.6 billion) and 33.1 per cent (RM6.7 billion) respectively. Meanwhile, the project owned by the public sector was underpinned by the Civil engineering sub-sector with a share of 75.1 per cent (RM10.4 billion) as in Chart 6.

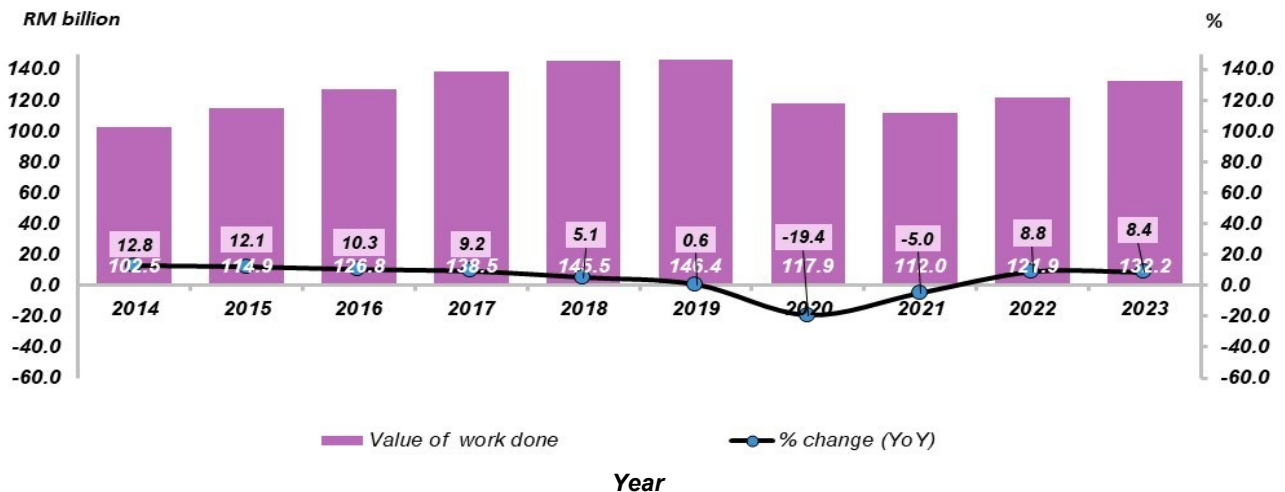
Chart 6: Value of work done by project owner Q4 2023



5. Annual Value of Work Done

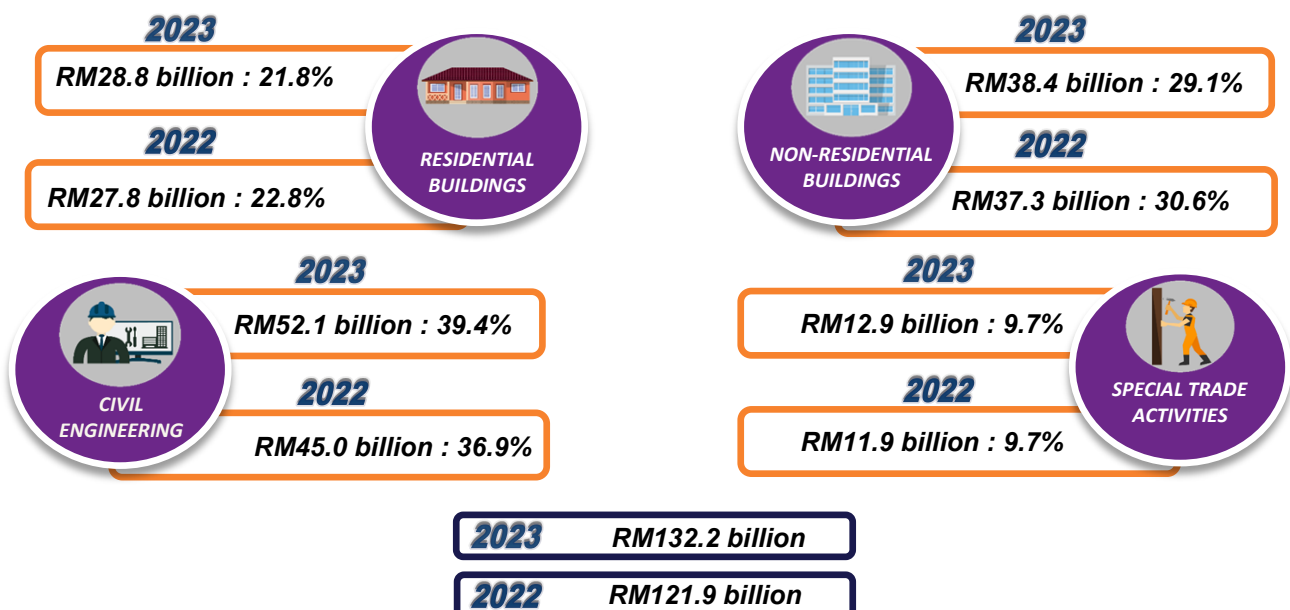
In 2023, the value of construction work done demonstrating continuous positive momentum at 8.4 per cent (2022: 8.8%) to RM132.2 billion as compared to RM121.9 billion in 2022 as in Chart 7.

All sub-sectors recorded positive growth in the value of construction work done as follows: Civil engineering (15.7%), followed by Special trade activities (8.5%), Residential buildings (3.7%) and Non-residential buildings (3.1%) sub-sectors. The Civil engineering and Non-residential buildings sub-sectors represented over two-thirds of value of work done in 2023 as in Exhibit 1.

- 1. Pendahuluan** Survei Pembinaan Suku Tahunan dijalankan dengan menggunakan pendekatan projek bermula daripada suku pertama 2006. Survei ini hanya meliputi kontraktor utama yang dianugerahkan dengan sesuatu projek. Nilai kerja pembinaan yang dilaporkan oleh kontraktor utama tersebut adalah jumlah keseluruhan nilai kerja yang dibuat tidak kira sama ada dilakukan oleh kontraktor utama atau sub-kontraktor. Memandangkan projek-projek hanya dianugerahkan kepada kontraktor utama, ia menyisihkan kemasukan sub-kontraktor dalam penyiasatan yang mungkin akan menimbulkan elemen pengiraan berganda dalam penyusunan data.
- 2. Objektif** Objektif utama Survei Pembinaan Suku Tahunan adalah untuk mengumpul dan menyusun data mengenai nilai kerja pembinaan untuk menerbitkan Statistik Pembinaan Suku Tahunan. Di samping itu, hasil penemuan survei digunakan dalam penyusunan Keluaran Dalam Negeri Kasar (KDNK) serta membantu kerajaan dalam perancangan ekonomi dan penggubalan dasar. Maklumat tersebut boleh juga digunakan oleh pihak swasta dan individu bagi tujuan membuat analisis ekonomi.
- 3. Kuasa perundangan** Survei ini dilaksanakan dibawah **Akta Perangkaan 1965 (Disemak 1989)**. Seksyen 5 di bawah akta ini menghendaki mana-mana pertubuhan yang beroperasi di Malaysia untuk memberikan maklumat sebenar atau anggaran terbaik kepada Jabatan. Mengikut akta ini, kandungan soal selidik adalah **sulit** dan hanya angka agregat diterbitkan.
- 4. Skop dan liputan** Survei Pembinaan Suku Tahunan melibatkan semua kontraktor utama yang menjalankan projek bernilai RM500,000 dan ke atas yang berdaftar dengan Lembaga Pembangunan Industri Pembinaan (LPIP). Liputan survei adalah terdiri daripada 72 industri pembinaan yang dikelaskan mengikut Piawaian Klasifikasi Industri Malaysia (MSIC) 2008 Ver.1.0. Aktiviti pembinaan yang berkaitan dengan penerokaan minyak dan gas tidak diliputi dalam survei ini. Senarai lengkap industri yang diliputi ditunjukkan di dalam Lampiran.
- 5. Kaedah pengumpulan** Survei ini dijalankan melalui soal selidik mel. Responden diberi tempoh dua minggu untuk melengkap dan mengembalikan soal selidik kepada Jabatan. Selepas tempoh tersebut, lawatan kerja luar akan dijalankan untuk mendapatkan respons daripada pertubuhan yang masih belum mengembalikan soal selidik berkenaan. Bagi kes yang belum respons selepas lawatan kerja luar, anggaran nilai kerja pembinaan menggunakan kaedah statistik yang bersesuaian akan dilakukan. Kadar respons semasa tamat penyiasatan adalah melebihi 90 peratus.
- 6. Kontraktor utama** Kontraktor utama adalah merujuk kepada orang, firma, dan lain-lain yang menerima tanggungjawab bagi menyiapkan keseluruhan sesuatu projek pembinaan. Satu kontrak dibuat dengan pemilik projek bagi kontraktor berkenaan menyiapkan sesuatu jenis kerja

binaan mengikut spesifikasi yang telah ditetapkan dalam perjanjian. Seseorang kontraktor utama boleh membuat keseluruhan kerja atau sub-kontrak keseluruhan atau sebahagian projek tersebut kepada satu atau lebih sub-kontraktor. Walau bagaimanapun, kontraktor utama adalah bertanggungjawab untuk memastikan semua kerja dibuat mengikut kepuasan pemilik projek.

- 7. Unit pelapor** Unit pelapor bagi survei ini ialah kontraktor utama. Unit ini melaporkan status kerja bagi setiap projek pembinaan yang sedang diusahakan.
- 8. Lokasi projek** Lokasi projek adalah merujuk kepada negeri di mana sesuatu projek pembinaan tersebut didirikan.
- 9. Nilai kerja pembinaan** Nilai kerja pembinaan yang dilakukan adalah termasuk pembinaan baru, pembaikan besar, pemulihan, pengubahsuaian dan pembaikan serta penyelenggaraan semasa yang dijalankan dalam tempoh rujukan untuk pemilik atau pelabur projek.

- 1. Introduction** *The Quarterly Construction Survey is conducted based on project approach starting from the first quarter 2006. This survey covers only main contractors who are awarded with the projects. The value of work done reported by these main contractors is the value of work done irrespective of whether the main contractor or the sub-contractor did the work. Since projects are only awarded to the main contractors, it eliminates the inclusion of sub-contractors in the survey which may create an element of double counting in the compilation of data.*
- 2. Objective** *The main objective of the Quarterly Construction Survey is to collect and compile data on the value of work done to publish Quarterly Construction Statistics. Furthermore, the findings of the survey are used in the compilation of Gross Domestic Product (GDP) as well as assisting government in economic planning and policy formulation. The data can also be used by the private sector and individuals for economic analysis.*
- 3. Legal authority** *The survey was conducted under the provisions of the **Statistics Act, 1965 (Revised 1989)**. Section 5 of this Act requires all establishments operating in Malaysia to provide actual information or best estimates to the Department. The Act stipulates that the contents of individual returns are **confidential** and only aggregated figures are published.*
- 4. Scope and coverage** *The Quarterly Construction Survey covers all main contractors with value of projects worth RM500,000 and above registered with the Construction Industry Development Board (CIDB). The survey coverage consist of 72 construction industries classified according to the Malaysian Standard Industrial Classification (MSIC) 2008. Construction activities related to oil and gas explorations are not covered in this survey. A complete list of the industries covered are shown in the Appendix.*
- 5. Method of collection** *The survey is conducted using mail questionnaire. The respondents are given two weeks to complete and return the questionnaire to the Department. After the said period, field visits are conducted to obtain response from the establishments which have not returned the questionnaires. As for non-response, the value of work done will be estimated using an appropriate statistical method. The response rate at the close of the survey was above 90 per cent.*
- 6. Main contractor** *Main contractor is a person, firm, etc. that accepts responsibility for completing the entire construction job. A contract is entered into with the owner of the project for the contractor to complete a certain type of construction work according to the specifications laid down in the contract. A main contractor may do all or sub-contract the whole or part of the project to one or more sub-contractors. However, the main contractor is responsible to see the whole work is done to the satisfaction of the project owner.*

- 7. Reporting unit** *The reporting unit of this survey is the main contractor. This unit reports on the work status of each of its construction project.*
- 8. Location of project** *Location of project refers to the state where the project is being carried out.*
- 9. Value of work done** *The value of work done includes new construction, major repairs, repairs, renovations and repairs and current maintenance carried out during the reference period for the project owner or investor.*
- 10. Type of construction activity** *The type of construction category used in the publication follows the MSIC 2008 ver. 1.0 :-*
- Residential buildings (41001)*
- Non-residential buildings (41002)*
- Codes 41003 and 41009 are classified under the residential or non-residential buildings based on the types of activity carried out*
- Civil engineering (42101-42106, 42109, 42201-42207, 42209, 42901-42906, 42909)*
- Specialized construction activities (Special trade) (43110, 43121-43126, 43129, 43211-43216, 43219, 43221-43229, 43291-43295, 43299, 43301-43307, 43309, 43901-43907, 43909)*
- 11. Public corporation** *The public corporation is set up under the laws passed by the Parliament Act or the State Legislative Assembly. It enables the government to be involved directly in the socio-economic development of the country. It consists of statutory bodies and non-statutory bodies which can operate and manage the government programs more independently. Examples of public corporations are Tenaga Nasional Berhad, Telekom Malaysia Berhad, Keretapi Tanah Melayu Berhad, etc.*
- 12. Rounding** *The sum of components may not add up to the total in the tables presented in this publication due to rounding.*
